6) Inquiry n1 – January 9th, 2018, 6:48 pm CET:

"There has to be a sender's address written on an envelope of the competition entry, when sending from foreign country. How is it possible to maintain the anonymity?"

Announcer's answer:

Announcer recommends according to Competition conditions to use as a sender's address the address of particular Chamber of architects, engineer or another public organization. See Competition conditions, page 12, 6.4.2

"Bearing in mind the need to adhere to the anonymity of the senders, for all competition entries submitted by post, a single sender's address must be used:

Czech Chamber of Architects, Josefská 6, Prague 1 – Malá Strana"

And in agreement with 6.4.3.

"If the competition entry is sent by post or any other public transportation of materials from outside the Czech Republic, the participant should, with regard to the necessity of maintaining anonymity of the sender, state as the address of the sender the title and address of the professional body in which the participant is registered under the legislation of the participant's country, or another public organization with which the participant has an agreement."

7) Inquiry n2 – January 9th, 2018, 6:48 pm CET:

"Also I want to ask if it is possible to send the panel packed as a roll to simplify the transport and avoid possible damages."

Announcer's answer:

Announcer states according to Competition conditions, page 10, 6.2.1 Graphic Section "The graphic section should be placed on 1 competition panel of A1 format vertically (dim. ca. 841 x 594 mm) of light material for exhibition purposes (hereinafter the 'panel')" that the material for exhibition purposes is fully at participants' discretion.

8) Inquiry n3 – January 9th, 2018, 10:28 am CET:

"Picture C5.2 doesn't suit our purposes to show our design the best way. Can we please use for the vizualization our own photo of front space for cinema from different angle?"

Announcer's answer:

Using the different picture for the above mentioned view is at the discretion of the participant. The Announcer recommends to use assigned photos for vizualization of front space and states that in agreement with the Competition conditions <u>6.2.1 Graphic Section</u> it is possible to add another sketches as "other diagrams and graphic materials per the participants' discretion" and as "other diagrams and graphic materials per the participants' discretion" in agreement with <u>6.2.2 Design Portfolio</u>

9) Inquiry n4 – January 10th, 2018, 4:21 pm CET:

"According to 6.2.1 g - Ground plan for solution of front space for Františky Plamínkové primary school – is it ment to use street intersection with Letohradská (assigned photo for vizualizatuion) or the part of the street Fr. Křížka between streets Kostelní and Skalecká?"

Announcer's answer:

"Ground plan for solution of front space for Františky Plamínkové primary school" means the part of the street Fr. Křížka between street Kostelní and street Skalecká where it is possible to show the proposed solution of the entrance to Letenské sady and the design of the space between Kostelní kindergarten and Františky Plamínkové primary school.
